- I agree to pay on the specified times, all tuition fees, and dues to JIC School.
- In the case of absence, withdrawal, or removal from the school or any of its services, I am still obliged to pay all applicable fees up until the current month.
- In case of withdraw from school written 30 day notice required. You are required to pay the remaining month's fee after the 30 day notice.
- I agree, once the student is granted admission to JIC, none of the paid fees is refundable. The late payment charge for the month will be \$25 per child. The NSF charge for cheque or preauthorized payment will be \$45.00.
- I further understand that: If the tuition fee is outstanding, the student will not be eligible to resume classes until such time as the outstanding amount has been cleared. I also understand that tuition fee is subject to change at any time.
- As a member of the JIC community, it's important to remember that all staff members have the right to be treated with dignity and respect at all times. Any form of threatening behavior, screaming or violence towards the staff is strictly prohibited and will not be tolerated under any circumstances. Please be aware that if any such behavior is exhibited by a parent or student, the offender may be asked to leave the premises immediately. Additionally, JIC reserves the right to terminate the enrollment of any student who displays aggressive behavior, or whose parent exhibits such behavior towards the staff.
- Grade 3 & 6 EQAO fee is \$65.00 per child. Parents are responsible for the fee.
- I understand that supervision is available from 8:30am and ends 3:30pm; I will pick and drop kids on time. JIC staff are not responsible before 8:30am and after 3:30pm. There will be late fees regardless of the inclement weather, traffic delays or other situations that may arise.
- The safety of your child is first and foremost, parents should come in and pick up kids after school, for safety reasons students cannot go outside without adult supervision.

- I understand that it is mandatory that my child comes to school in clean and proper uniform. All uniforms must be from Dido colours with school logo.
- Pictures or videos of the students may be taken on outings, activities, and events in the school. These pictures will only be used by the school, published in the school newsletter, and/or posted on the school's website.
- I grant permission for a photo/image/video that includes this student to be published on the school and school website and promotion of the school.
- I grant permission for my child to participate in all school activities.
